1. ORGANIZER

2. GENERAL INFORMATION

NextGen Handball Europe is an international youth handball tournament open to clubs across Europe.

Participation in the tournament is subject to acceptance of these Terms and Conditions.

3. PARTICIPATION

The tournament is open to handball clubs participating with teams in the following categories:

GIRLS:

U12 - players born 2015 and 2016

U14 - players born 2013 and 2014

U16 - players born 2011 and 2012

BOYS:

U13 - players born 2014 and 2015

U15 - players born 2012 and 2013

4. REGISTRATION

Teams must register through the official registration process provided on the website www.nextgen-handball.eu

Participation is confirmed only after:

- completed registration
- payment of the participation fee

5. PARTICIPATION FEE

The participation fee covers the sporting component of the tournament, including:

- tournament participation
- referees and match officials
- competition management
- awards and medals
- tournament organization

Accommodation and travel services are not included in the participation fee unless explicitly stated.

6. ACCOMMODATION

Teams may book accommodation independently or through recommended accommodation partners.

Accommodation arrangements are separate from the tournament participation fee unless otherwise specified.

7. PAYMENT CONDITIONS

Payment details and deadlines will be communicated to registered teams.

Failure to complete payment by the specified deadline may result in cancellation of participation.

8. CANCELLATION POLICY

If a team cancels participation after confirmation, the organizer reserves the right to retain part or all of the participation fee depending on the timing of the cancellation.

The organizer may cancel or modify the event due to force majeure circumstances such as natural disasters, government restrictions, or other events beyond reasonable control.

9. LIABILITY

Participation in the tournament is at the own risk of participants.

The organizer shall not be liable for injuries, accidents, loss, theft, or damage to personal belongings during the event.

Teams are responsible for the behavior and supervision of their players and officials.

10. INSURANCE

Each team and participant is responsible for obtaining their own health, travel, and accident insurance coverage.

11. MEDIA AND IMAGE RIGHTS

By participating in the tournament, participants agree that photos, videos, and other media captured during the event may be used by the organizer for promotional and communication purposes without additional compensation.

12. DATA PROTECTION

Personal data collected during the registration process will be processed in accordance with the Privacy Policy published on the website.

13. WEBSITE USE

14. GOVERNING LAW

These Terms and Conditions shall be governed by the laws of the Republic of Croatia.

Any disputes shall fall under the jurisdiction of the competent courts in Croatia.
